






GENERAL STANDARD OPERATING PROCEDURE (SOP) VGM AND CHARGES FOR JOHOR


1.0. <u>Amendments to SOLAS Chapter VI, Part A, Regulation 2 - Verified Gross</u> Mass (Weight).

- 1.1. Summary of SOLAS VGM regulation change:
 - 1.1.1. A <u>shipper</u> must <u>verify the gross mass of a container</u> by either *one of two methods*:
 - i. Weighing the container after it has been packed using calibrated and certified equipment or;
 - ii. Weighing all the cargo and contents of the container and adding those weights to the container's tare weight using a certified and approved method.
- 1.2. The <u>shipper</u> must <u>ensure</u> that the <u>verified gross mass</u> is stated in the <u>shipping document</u> and submitted to the *ship master and terminal operator* for stowage planning.
- 1.3. If the verified gross mass is not obtained by the ship master and terminal operator, the container cannot be loaded on the ship.
