Dengan segala hormatnya saya merujuk kepada perkara di atas.

2. Untuk makluman pihak Dato'/Tuan/Puan, Mesyuarat Jawatankuasa Pemandu Projek uCustoms (JPPuC) Bilangan 6/2013 yang dipengerusikan oleh Ketua Setiausaha Perbendaharaan (KSP) telah memutuskan untuk melantik satu jawatankuasa khas bagi mengkaji peranan Service Provider (SP) dan melantik syarikat yang akan beroperasi sebagai SP. Hasil dari penilaian *National Single Window (NSW) Service Provider (SP)* yang telah dilakukan pada 22hb Jun 2015, pihak jawatankuasa khas telah memutuskan untuk memilih dua syarikat iaitu DagangNet Sdn. Bhd. dan Edaran Tradenetwork Sdn. Bhd. sebagai NSW SP bagi projek uCustoms.

3. Secara dasarnya, pelantikan SP dilihat dapat membantu untuk menjayakan pelaksanaan NSW dengan menyediakan *end-to-end services* kepada komuniti perdagangan dengan menawarkan perkhidmatan seperti *Electronic Declaration, Electronic Manifest, Electronic COO* dan *Electronic Permit* yang turut disediakan di dalam sistem uCustoms. Di samping itu juga, pihak SP juga akan menawarkan *Value Added Services (VAS)* bagi memenuhi permintaan khusus yang bermanfaat kepada pelanggan. Walaubagaimanapun, pihak SP akan mengenakan caj yang kompetitif yang akan ditentukan sendiri oleh pihak SP tersebut bagi setiap perkhidmatan yang disediakan. TANGGUNGJAWAB NATIONAL SINGLE WINDOW (NSW) SERVICE PROVIDER (SP)

- i) The SP is responsible to design, develop, install, test, commission, operate and maintain the SPWP that will front the NSW Users in providing services in relation to trade facilitation and access to services that are part of the NSW system.
- ii) The SP is responsible for providing end-to-end support, operation and maintenance functions including Core Services and VAS. The SP must ensure 99.9% availability to access the Core Services and VAS SP, and ensure that additional services offered creates value and enriches the customer's experience;
- iii) The SP is responsible for providing effective and efficient support to the NSW Users in the form of a call centre which is to be operated 24x7 and within the Service Level Agreements (SLA) established by the Government.
- iv) The SP is responsible to provide on-going and ad-hoc trainings to the NSW users;
- v) The SP is responsible for developing, maintaining and updating SOPs to facilitate the process and procedures required in the NSW. SOPs can be used in the case of running periodic maintenance throughout the duration of the contract with the Government;
- vi) The SP must work closely with the NSW Operator and the NSW Lead Agency to provide Core Services and VAS maintained and operated by the NSW Operator. A strong SLA needs to be established between the SP and the NSW Operator to ensure minimal disruption in connection between the SP and the NSW Operator; and
- vii) The SP is required to address all issues in regards to the NSW operation and would seek prior approval from the Government (via the Lead Agency) for any decisions which require changes to the NSW environment. Possible issues that are raised with regards to the NSW operation could be in the form of:
 - System integration to NSW Operator that is hampered due to software issues; or
 - Non-compliance of SLA from other stakeholders such as NSW Operator.

- viii) The SP must adhere to the policies, guidelines and restrictions set by the Government in the national interest of safeguarding the NSW.
- ix) The SP is responsible to create awareness, to reach out to the trade community and to increase trade in Malaysia.
- x) The SP must also provide training on its services and provide feedback to the Government on how trade can be improved where necessary.
